

### **HOW YOUR DEGREE WORKS**

Your LLB course will be three years in length.

**First-Year**: Although the grades you obtain do not count towards your degree classification, you must try and achieve the best grades possible, as they are considered by law firms and chambers when viewing applications. First year modules are compulsory and they consist of:

Law of Contract 1
Public Law and Human Rights
Criminal Law
Law Reform
Legal Systems, Ethics & Skills
Law in Practice 1: Legal Communication

**Second Year**: The grades you obtain in your second - year count towards your degree classification. Your second - year modules are also compulsory, and consist of:

European Union Law
The Law of Torts
Law of Contract 2
Law of Business Enterprises
Law in Practice: Commercial Awareness
Law of Property

**Third Year**:In addition to undertaking a compulsory Equities & Trusts module, you must pick 5 other modules to complete.

### **ACADEMIC GUIDANCE TUTORS**

During welcome week, you will be assigned an Academic Guidance Tutor (AGT). Should you be unsure who your AGT is, you will find a list on the law school notice board on the third floor in the Duchesne building. Your AGT is there to ease your transition to university. 
### **OUTSIDE OF THE LAW SCHOOL:**

### MAKING YOURSELF MORE EMPLOYABLE

"In today's competitive marketplace, employability skills are key. Law students tend to prioritise the acquisition of knowledge over the acquisition of skills, but this is not a good idea" (Legal Systems & Skills, 2017). Although good academics are important, prospective employers such as law firms, take a holistic approach to viewing each candidates application. You must develop along with good academics:

Your networking skills; Your LinkedIn profile; Extracurricular activities; Commercial Awareness

### **NETWORKING**

Essentially, networking involves building strong lasting relationships with others who can help you achieve your goals whether in your academic or professional life. You can improve your networking skills, by:

- Attending Law Society Networking Events;
- Attending networking events organised by Bright Network, Legal Cheek and Aspiring Solicitors;
- · Creating a LinkedIn profile and connecting with like-minded people and professionals in your sector.

### **EXTRA CURRICULAR ACTIVITIES**

Whilst at Roehampton, there will be many opportunities to engage with societies, sports teams and other extracurricular activities. Prospective employers and law firms seek candidates who have a good academic record but also engage with extracurricular activities. To become a well – rounded person, and to gain valuable skills you should consider:

Joining a society (We advise joining three: one associated with your academic studies, one associated with cultural, religious or general interests, and one where you can remain fit and active);

Taking up positions of responsibility by running for a position on a society's committee during elections;

Running in the RSU elections.

### **COMMERCIAL AWARENESS**

### What is it?

"Commercial awareness can simply be defined as staying up-to-date on daily happenings and developments in the business and commercial world. A significant portion of law today revolves around business and commerce in the marketplace, between cities and regions, and across geographies. Commercial awareness is, therefore, one of the key requirements that a good and competent solicitor needs to master" AllAboutLaw.co.uk

### How do you become commercially aware?

You can increase your commercial awareness by keeping up to date with commercial news and understanding the impact they have on the legal and financial sector. Sign up to **Bright Network's** or **The Corporate Law Academy's** weekly updates on the important commercial issues facing law firms and their clients.

### Why is it important?

"The role of a solicitor is not only a technician of the law but also a sound business adviser. This helps explain why firms are so keen for you budding lawyers to be commercially aware and not just a high achieving student. A lawyer must assist clients to achieve their business aims. As commercial awareness also involves being up to speed with the political, economic and social frameworks, firms only offer positions to those who can demonstrate this. Firms want to know you will keep up with being commercially aware after your training, so if you start it now and make a habit of remaining business savvy, this will benefit your applications" AllAboutLaw.co.uk

### DIFFERENT TYPES OF LAW FIRMS

### 'Magic Circle' law firms

The Magic Circle refers to five UK- based firms "considered to be amongst the most prestigious in the world" (Chambers UK) Their elite status comes from various factors, which includes their client base, revenue per equity partner and their international presence. The five members of the magic circle, in no particular order, are Allen & Overy, Freshfields Bruckhaus Deringer, Slaughter and May, Clifford Chance, and Linklaters.

### The 'Silver Circle' law firms

In essence, the silver circle refers to the band of firms that fall just below the magic circle when it comes to turnover, but post considerably higher profit per equity partner (PEP) and revenue per lawyer (RPL) averages than the rest of the nation's legal market. These are all traditionally considered to be London-centred firms too, though most of them have an international outlook and network of overseas offices (Chambers UK). The five members of the Silver Circle, in no particular order, are Travers Smith, Macfarlanes, Herbert Smith Freehills, Ashurst, and Bryan Cave Leighton Paisner.

### **Regional law firms**

Some regional firms are large and might do work on a national level even if the firm doesn't have offices dotted across the country. Others are small to medium-sized outfits with their headquarters in a small city and several offices across one region of the UK. Others might just have one office in a provincial town serving local businesses and wealthy individuals. Like their London and big-city counterparts these are still commercial firms, distinct from high-street and public interest firms in that they don't take a chunk of their revenue from legal aid (Chambers UK).

### **National law firms**

National firms are firms which have "at least three offices in England and Wales, and offices in different English Regions both in the North and the South; and at least three UK- wide or 'national leader outside London' Chambers UK ratings" (Chambers UK)
